# Foreword by new APUO President

Welcome to the fall term! As newly elected President of the APUO I would like to present some of the upcoming priorities for the APUO in the next few months.

**Collective bargaining:** As a condition to begin bargaining early, the employer insisted that APUO attend a full-day preventive conciliation meeting on October 5 2015. We would like to begin early because it is beneficial to our members to have a new agreement in place by the time or very soon after the current contract expires, unlike past practice where we have gone months and even years with no contract in place. The current agreement expires on April 30 2016.

The Collective Bargaining Committee has been meeting regularly since the spring to develop our positions and proposals, which will be presented to members at the General Meeting on November 3 2015 from 9:00 to 11:00 a.m. in room TBT 112. Please attend and vote on these proposals. The negotiating team is in a stronger position if it is clearly aware of members' priorities.

**University Governance:** Governance at the University of Ottawa is a pressing issue especially in view of the *privatisation* of our governing bodies (the Senate, which oversees academic affairs and the Board of Governors which manages the finances). Quite suddenly, videos of meetings which had previously been available online are now restricted, private videos on <u>YouTube</u>. Similarly, minutes of these meetings are no longer online. It is worth noting that other universities, including the University of Ontario Institute of Technology (which was in the news this past summer for its closed door policy) and Carleton University have restricted the public's access

to either or both of these governing bodies at their respective institutions (see <u>Carleton BoG Blog</u> for a description of how access to the Board of Governors is prevented at Carleton). We should not forget that our universities are publicly funded institutions and are intended to serve the public interest. I encourage you to attend these meetings in person while you still can: Senate meets once a month on Mondays from 3:00 to 5:00 p.m. in the Senate chamber, Tabaret Hall (TBT 083). The Board of Governors meets also on Mondays (usually two weeks after the Senate) at 5:30 p.m. also in the Senate Chamber (TBT 083).

Governance is by no means restricted to the Senate and Board of Governors, however. For example, in June, the Institute of Population Health was shut down despite the vocal resistance of several student and professor members of Senate. The senior administration ram through such an important change affecting faculty and dozens of graduate students – many of whom watched the Senate meeting from the public gallery – without any serious consultation process.

**Inter-union affairs:** Did you know that APUO meets regularly with the other unions on campus? The inter-union group includes:

- APTPUO (Association of Part-time Professors of the University of Ottawa)
- CUPE 2626 (Union of Student Workers at the University of Ottawa)
- GSAÉD (Graduate Students' Association)
- IUOE (International Union of Operating Engineers)

- PIPSC (Professional Institute of the Public Service of Canada)
- SFUO (Student Federation of the University of Ottawa)

We collaborate with our colleagues in various ways to promote and defend the interests of the entire university community. One recent initiative was the open letter to the Board of Governors concerning Vice-President, Research Dr. Mona Nemer's sudden and steep salary increase in 2014 (full details are available on the APUO website).

The inter-union group also meets regularly to discuss common strategies regarding the pension plan (because many University of Ottawa employees contribute to it, not just APUO members) and we are currently working on a strategy to expand the availability of child care on or near campus for all members of the University of Ottawa community.

## Board of Governors' budget approval 2015-2016

On May 25, 2015 the Board of Governors approved the University's 2015-2016 budget. In his message the Vice-President of Resources states that: "the University has adopted a series of measures to reduce spending by \$10.4 million, limit expenditure growth and a number of one-time cost reductions."

As the APUO has demonstrated on several occasions previously, the University's financial position has been and continues to be extraordinarily strong. You can read APUO's response to the 2015-2016 budget approval in our letter to the Board of Governors.

# Letter to Board of Governors concerning results of APUO survey regarding next President

As most of our members know, the APUO conducted a survey among its members from December 9 to 18 2014 to determine their preferences and views concerning the next President and the selection process. The summary of the results clearly indicates that the next President of the University of Ottawa must have a Ph.D., be a tenured professor (here or elsewhere) in any field, have management experience in a university setting (preferably a former dean), preferably be a woman, a member of a visible minority or Aboriginal and, lastly, not be a well-known public figure.

#### APUO Award for Excellence in Research

## **OCUFA/CAUT News and Events**

**Survey on workplace stress:** OCUFA and CAUT are partnering with the Occupational Health Clinics for Ontario Workers (OHCOW) to launch a survey on workplace stress this fall (planned for October/November 2015). This survey builds on OCUFA's recent workshop *After Bill 168: Occupational Health and Safety in the Academy* and focusses on the number one issue of faculty: workload. It is important to have a high response rate in order to reinforce credibility of reports for the responding institutions and ultimately to develop proposals to enhance safety and well-being of members and improve workload and conditions. APUO will keep you informed.

**CAUT Briefing note on outsourcing:** Several universities and colleges have or are considering outsourcing their IT systems to cloud computing providers such as Google and Microsoft 360. CAUT has written a <u>briefing note</u> examining the impact this has on the academic freedom and privacy rights of staff, and what academic staff associations can do to challenge outsourcing.
